4. OWNERSHIP

Seller guarantees that is the true and lawful owner of the above described vehicle and that it is free of all encumbrances, any and all legal claims.
 Parties agree to sign all documents necessary to transfer ownership of the vehicle from Seller to the Buyer within thirty (30) days of signing this purchase agreement.
 Buyer shall be liable for all administrative costs relating to the registration of the vehicle onto his/her name and all costs relating to the Roadworthy Certificate.

5. PURCHASE PRICE AND PAYMENT METHOD

The purchase price is set at **\$27,160**, with an additional delivery fee of **\$937**.
 Consequently, the total amount payable is **\$28,097**.
 The purchase price encompasses all applicable taxes, including state, local, municipal, and sales taxes.

The payment will be completed by Bank Wire Transfer.
 Buyer requests the wiring information only after signing this purchase agreement.

6. MONEY BACK GUARANTEE

V LINE AUCTION, LLC. provides a 30-day Money Back Guarantee, allowing the Buyer to return the product for a full refund of the purchase price if the product is found to be inaccurately described or represented. To initiate the return process, the Buyer must notify V LINE AUCTION, LLC. within five (5) days of receiving the product, but no later than fifteen (15) days from the date of sale. This notification should be directed to the Seller via phone or registered email address.

Additionally, the product is covered by a comprehensive 5-day warranty from V LINE AUCTION, LLC. However, this warranty does not extend to any physical damage incurred after the inspection period.

The inspection period begins the weekday following the delivery date, as Buyer acknowledges and signs on the delivery receipt. The purchased product must not be utilized or modified beyond the necessary verification of its condition, and its usage should not exceed five hours or 60 miles from the time of sale.

In the event of a return, Buyer is not responsible for freight and handling charges. The Seller commits to issuing a full refund to the Buyer within 24 hours upon the return of the item. Should the Buyer choose to return the vehicle, the Seller agrees to cover all associated costs.

7. ADDITIONAL PROVISIONS

The Seller confirms ownership of the product detailed in Paragraph 3 (Object of Sale) and possesses the authority to sell it to the Buyer at the purchase price and method specified in Paragraph 5 (Purchase Price and Method). The Seller assures that there are no liens or encumbrances associated with the product and certifies that the information provided in this Purchase Agreement is true, accurate, and complete to the best of their knowledge.

Both Buyer and Seller agree that the product described in Paragraph 3 will be sold by the Seller and purchased by the Buyer on an "as is" basis and in its current condition. The agreement includes a 30-day money-back guarantee for the specified product. The Buyer accepts full liability for the product upon its arrival.
